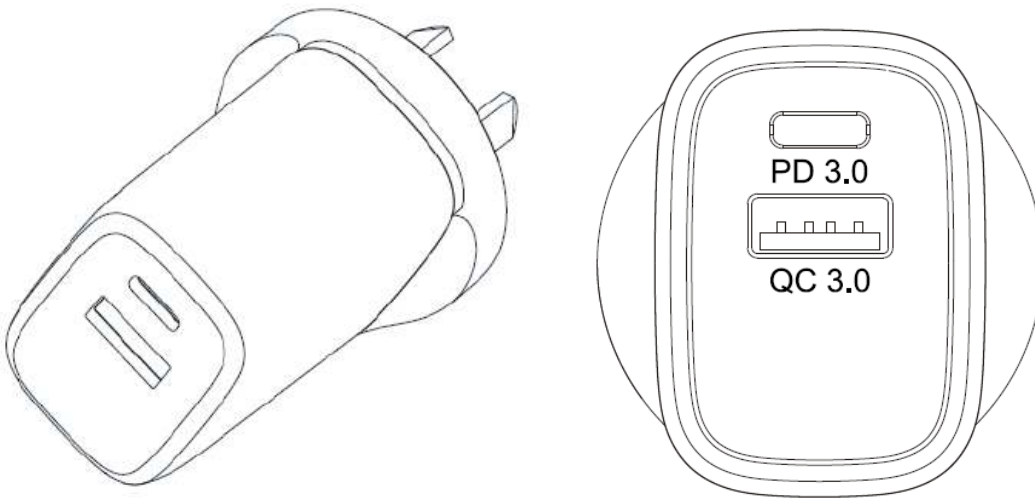

Support USB-C Power Delivery 3.0 (20W max) and Quick Charge 3.0 (18W max) fast charging devices (iPad, iPhone, iPod, Samsung and other Android smart phones, tablets).



Safety Notes

4. Charging two devices simultaneously at standard charge.
