Golden Jubilee Overdrive & Distortion

Quick Reference Guide

GOLDEN JUBILEE

The Golden Jubilee is a very special circuit designed to celebrate the best of classic British voiced and American voiced High Gain Amp tones in a single compact pedal

Input: from Instrument ▽

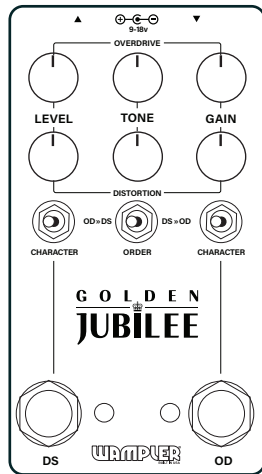
Output: to Amplifier △

The Golden Jubilee has two channels - **Distortion (DS)** and **Overdrive (OD)**. Each channel shares a common control set as described below:

Level: Controls the total output volume. Turning clockwise increases.

Tone: Adjust the amount of high-end, turning clockwise will increase the high-end frequencies present.

Gain: Turning clockwise increases amount of gain.

DS Character: Adjust between Bright (Left) and Dark (Right).

OD Character: Adjust between Normal (Left) and Hard Clipping (Right).

Order: Adjusts the order that the channels run into each other - Left position is OD into DS, Right position is DS into OD.

Power: This pedal was designed around the usage of a 9-18V DC power source.

To avoid damage to the pedal, do not exceed 18V DC, do not use center pin positive adapters, and do not use AC power.

Use only a 9-18V DC power source that is intended for guitar pedals.

This pedal draws approximately 30mA at 9V and 30mA at 18V.

Some of Brian's suggested settings - use these as a starting point to find your perfect tone.



Blues Crunch

Mild breakup, great for the blues



Classic Crunch

Harder distortion, great for classic rock



Lead Boost

Low to medium gain transparent - like an extra amp gain channel



Meaty Distortion

Heavier, thicker distortion with plenty of grunt



Solo Crunch

High gain solo tones, crunchy, mid focused



Fluid Solo

Creamy liquid articulation, great solo tone with a beefy low end

A Return Authorization Number must be obtained from our Customer Service Department prior to shipping the product. Products must be shipped in their original packaging or its equivalent; in any case, the risk of loss or damage in transit is to be borne by the purchaser. The Returns Authorization Number must appear in large print directly below the shipping address. Always include a brief description of the defect, along with your correct return address and telephone number. When emailing to enquire about a returned product, always refer to the Return Authorization Number. If WAMPLER determines that the unit was defective in materials or workmanship at any time during the warranty period, WAMPLER has the option of repairing or replacing the product at no additional charge, except as set forth below. All replaced parts become a property of WAMPLER. Products replaced or repaired under this warranty will be returned via ground shipping within the United States freight prepaid.
